

# Housekeeping Notes

---

- All attendees are required to wear the name tags or lanyards and badges issued to them by the Credentials Committee upon registration in order to be admitted to the ballroom or to any ticketed event.
- During the annual business meeting, only credentialed delegates are permitted in the delegate seating area. Non-delegate attendees should be seated in the area designated as “Guest Seating.”
- The hotel prohibits outside food and beverages in the ballrooms. Coffee or other drinks purchased at The Canteen or from the Cash Bar are permitted.
- Tickets are required for all meals and Guest Speaker events. Those who do not hold tickets for these events must exit the ballroom promptly upon lunch recess and adjournment.
- Please enjoy Saturday evening’s Cocktail Hour in the Upper Terrace, just outside the ballroom doors. The ballroom must be clear for dinner set-up.
- Restrooms are located outside the ballroom. The closest ones are to the left as you exit, just across the hall. Others are located in the hallway across from The Canteen.

# Special Convention Rules

---

1. All primary amendments to the Platform or Bylaws must be submitted in writing to the Convention Secretary. All such primary amendments must be legible and: contain the names of the author and co-sponsor(s); contain the full language of the proposed amendment; specify the Article and Section of any current bylaw, or the platform plank, that would be impacted.

- Substitute motions to proposals from the Bylaws & Platform Committee shall be submitted prior to those recommendations being taken up by the assembly.
- Motions unrelated to proposals from the Bylaws & Platform Committee shall be submitted prior to New Business, when such motions may be considered.

2. All resolutions, any motion to appeal a decision of the Judicial Committee, or any other action to be considered by the assembly not previously addressed on the agenda must be submitted in writing to the Convention Secretary prior to New Business, when such proposals may be considered. All proposals must be legible, contain the full language of the motion or resolution, and include the name of the author.

3. Debate on any motion or amendment is limited to two minutes per speaker and each Delegate is allowed to speak only twice to their argument. Discussion on any particular motion shall be a maximum of twenty (20) minutes.

4. Nominees will have opportunity to speak to their nominations after the close thereof. Nomination speeches shall be limited to one (1) minute per candidate. The Chair shall have discretion to limit speeches further as necessary.

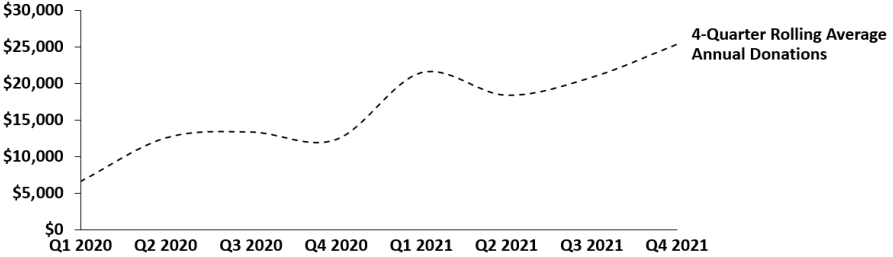

# OKLP Elections

---

## **State Executive Committee (OKLP Bylaws Article VII)**

- Controls and manages all affairs and properties of the OKLP between State Conventions
- Two-year terms beginning in odd-numbered years
- Elections during this convention for vacant seats will be for the remainder of the current term, which ends in 2023
- Members must meet all OKLP Membership criteria and not hold more than one elected State Party office or seat on the State Executive Committee

## **Judicial Committee (OKLP Bylaws Article VIII)**

- Appellate authority for the OKLP
- Five members elected to two-year terms beginning in even-numbered years
- Members shall have been OKLP Members for at least two years, have attended at least two State Conventions, and not be members of the State Executive Committee
- Three alternates are elected to fill any vacancies which may occur

## **Bylaws & Platform Committee (OKLP Bylaws Article XII)**

- Responsible for preparing and submitting recommendations for amendments to the existing OKLP Bylaws and Platform
- Elected at each State Convention and serve until adjournment of the subsequent State Convention
- Members may not have been elected to the State Executive Committee for the same term

## **2022 Libertarian National Convention Delegates (OKLP Bylaws Article XV)**

- Twelve seats allocated to Oklahoma by the Libertarian National Committee for 2022
- Qualified candidates must be residents of Oklahoma for at least ninety days prior to the State Convention, Members of the OKLP for at least ninety days prior to the State Convention, and a sustaining member of the national Libertarian Party on the day the delegation allocation counts were calculated (October 31, 2021)
- National Convention Delegates will represent the OKLP at the 2022 LNC Convention taking place May 26 - 29th in Reno, Nevada
- Delegates from Oklahoma bear responsibility for their own tickets, travel, meal, accommodation, and other arrangements and expenses related to attendance at the national convention

# Bylaws & Platform Committee Report: Platform

---

## **Proposal 1: Property Rights Plank**

### PROPOSED AMENDMENT

#### 5.0 Property Rights

We recognize the individual's right to own property as natural and self-evident, and advocate private property rights for all. We condemn all fraud and initiatory violence toward a person's life, liberty, or property. We contend that private property is the best way to reduce and reconcile conflict between individuals. We categorically reject socialism, defined as the state-controlled seizure and collectivization of resources.

Strike "Individuals have an inalienable right to own property," from Plank 1, as adding this amendment makes that sentence redundant.

## **Proposal 2: Secession Plank**

### PROPOSED AMENDMENT

6.0 Right of Secession We agree with the sentiment expressed in the Declaration of Independence that whenever a government becomes destructive of the inalienable rights with which its people are endowed, "it is the right of the people to alter or to abolish it." As such, we believe in the unequivocal right to political self-determination through the peaceful act of secession.

# Bylaws & Platform Committee Report: Bylaws

---

## Recommendation 1: Judicial Committee Voting Records

### REASON

The delegate body expects transparency in all state committee proceedings whenever possible. Currently there is no requirement that the Judicial Committee voting records be made public and attributable (roll call vote).

### IMPACT

This amendment will require Judicial Committee votes to be made public record.

### PROPOSED AMENDMENT

Article VIII: Section 9. Final votes on all matters shall be made public including attribution by using a roll call vote.

## Recommendation 2: Advanced Notice

### REASON

Delegates need advance notice of substantial amendments to the Rules of Appellate Procedure that will be presented at convention.

### IMPACT

This amendment requires any proposed substantive changes to the Rules of Appellate Procedure, to be submitted to the State Secretary at least forty-five (45) days prior to convention.

### PROPOSED AMENDMENT

Article VIII Section 6: The Judicial Committee shall use the most recent edition of the 2021 OKLP Judicial Committee Rules of Appellate Procedure unless and until it submits to the State Convention new proposed rules to be adopted by the delegates at which are adopted by a fifty percent plus one (50% + 1) majority approval of that State Convention. Such proposed rules shall be submitted to the State Secretary no less than forty-five (45) days prior to convention for publication.

### Recommendation 3: Amendment of Bylaws

#### REASON

Delegates need advance notice of substantial amendments to the Bylaws that will be presented at convention.

#### IMPACT

This amendment requires any proposed substantive changes to the Bylaws to be submitted to the State Secretary at least thirty (30) days prior to convention.

#### PROPOSED AMENDMENT

Article IV, Section 1: H. Unless otherwise stated in these Bylaws, substantive amendments to the Bylaws shall be submitted to the State Secretary no less than thirty (30) days prior to convention for publication.

## Recommendation 4: Removal of Certain Requirements

### REASON

Certain reporting requirements found in the Bylaws affect only the operation of the State Executive Committee and are better codified in Standing Rules or a "Policy & Procedures Manual".

### IMPACT

This amendment gives the State Executive Committee the ability to change its own reporting requirements for certain members of the committee rather than burden the Bylaws.

### PROPOSED AMENDMENT

Article VII Section 5: At-Large Representatives, in addition to being available to all Members, shall under the direction of and in coordination with the Chair and Vice Chair assist in the achievement of the Party's Purpose as stated in Article II of these Bylaws, ~~Each At-Large Representative shall submit to the Secretary seven (7) days prior to each regular meeting a written report of all activities~~ related to the responsibilities with which the person has been charged in accordance with one of the following roles:

~~Section 6. Each Regional Representative shall submit to the Secretary a written report of all activities within that person's region seven (7) days prior to each regular meeting.~~

## Recommendation 5: Other Committees

### REASON

The Bylaws and Platform Committee (formerly “Rules Committee”) was moved last term under Permanent Organization and given its own article. For clarification and proper formatting, we intend to simplify the bylaws by moving the Bylaws and Platform Committee into the Other Committees section, where it was listed prior to the 2021 convention.

### IMPACT

Moving Bylaws/Platform back under “Other Committees” simply puts it back to the old structure from 2020. No functional changes are being made.

### PROPOSED AMENDMENT

Article VI Section 4: The permanent organization of the OKLP shall consist of an at-large governing body known as the State Executive Committee, a Judicial Committee, ~~a Bylaws & Platform Committee~~, and County Affiliates represented by seven (7) Regional Committees

~~Article XII: Bylaws and Platform Committee~~ (Strike entire section)

### **Article XIII: Other Committees**

Section 4. The Bylaws and Platform Committee will be composed of the State Chair and four (4) Members elected by the Delegates at the State Convention to serve until adjournment of the subsequent State Convention and who have not been elected to the State Executive Committee for the same term. The State Chair shall have the option to appoint a Member who has served on at least two (2) previous OKLP Bylaws Committees (formerly “Rules”) to serve as the Chair’s designee. Neither the State Chair nor that person’s designee may vote except in the case of a tie. The committee shall choose its own chair from the four (4) elected members. Vacancies on this committee occurring after the State Convention shall be appointed by the State Chair with the approval of the State Executive Committee. The Bylaws and Platform Committee shall prepare and present to the State Executive Committee, no later than forty-five (45) days prior to the subsequent State Convention, a document for publication containing any proposed amendments to the existing Bylaws and Platform. Such document shall contain any proposed changes, related existing wording in the Bylaws, the effect of the proposed changes, and any committee opinions in support or opposition.



## **Recommendation 6: Article VII: State Executive Committee**

*PUBLICATION NOTE: The appearance of Recommendation 6 in this booklet differs from that of the Bylaw & Platform Committee's submitted report (available for viewing using the QR code on Page 2 of this booklet) in order to present the Proposed Amendments to each section of Article VII along with the boxed information showing the Current Bylaw side-by-side with the Proposed Bylaw As Amended.*

### REASON

In light of the issues surrounding the vacancies of our own board and those of the Libertarian National Committee, the members of the Platform and Bylaws Committee felt it best to tighten up the language in our own bylaws to give guidance for matters concerning the State Executive Committee. The current bylaws do not allow for the suspension or removal from office of elected members within the OKLP with or without cause. The language concerning vacancies in regards to the Chair is also not very clear. We also propose taking out redundant and extraneous language in Section 8.

### IMPACT


Sections 9 and 10 are being added to address any scenario whereby an elected Officer, At-Large Representative, Regional Representative, or other Member elected to a position within the OKLP is suspended and recommended for removal from office. This also clarifies how vacancies are handled in most cases. There are also a few minor changes for ease of reading and one grammatical oversight that is corrected. Titles were added back to each section for searching purposes. The non-substantive changes are not reflected in the synopsis below but are in the amended language in the following table.



- D. Failure or refusal to disclose necessary information on matters of OKLP business.
- E. Unauthorized expenditures, signing of checks, or misuse of OKLP funds.
- F. Misrepresentation of the OKLP and its officers to outside persons.
- G. Actions that directly violate the Statement of Principles or the Non-Aggression Principle.

## PROPOSED AMENDMENT: Section 10. Removal From Office

*PUBLICATION NOTE: this is an entirely new section of the Bylaws with no existing "CURRENT BYLAW" against which to compare it; therefore, the boxed section shown in the Bylaws & Platform Committee's original report (available for viewing using the QR code on Page 2 of this booklet) has been omitted here.*

Section 10. Removal From Office. In the event an Officer, At-Large Representative, Regional Representative, or any elected committee member within the OKLP is suspended, the Executive Committee shall within ten (10) days of a suspension hold a Special Meeting to appoint an Investigative Committee.

### A. The Investigative Committee

1. The Investigative Committee shall consist of no less than three Members, who shall have been a Member of the OKLP for at least two years, attended at least two conventions, and are not current members of either the Executive Committee or Judicial Committee.

2. The Investigative Committee shall report its findings to the Executive Committee within thirty (30) days of being appointed.

3. Nothing in this section shall be construed as prohibiting the Investigative Committee from seeking outside expertise not to exceed a cost specified by the State Executive Committee in the annual budget.

B. The suspended Officer, At-Large Representative, Regional Representative, or elected committee member may seek an appeal to the suspension in a separate proceeding.

C. If upon review of the Investigative Committee's petition, the Executive Committee rules there is not sufficient cause for removal, the suspension will be lifted.

## Recommendation 7: Article V: Membership

### REASON

Every year there is inevitably an instance where a Member comes to convention and for one reason or another their voter registration information is not found in the voter database by the Credentials Committee. Until this past year we have not had an official mechanism by which to allow these Members to be seated as delegates though they meet all other criteria to be a delegate. In the past we have mistakenly “suspended the bylaw” to allow those Members to be seated. This past year we corrected that mistake, but inadvertently created a loophole which would allow people who do not qualify under any terms to be seated if approved by a simple majority. This amendment seeks to remedy that.

### IMPACT

This language clarifies who may be eligible for a waiver of the membership terms to be a delegate at the State Convention. This amendment also clarifies that Members are not required to have any further financial outlays in order to participate in Party business.

### PROPOSED AMENDMENT

Section 1. D. Section 6. A Member shall have the right to participate in the official affairs and governance of the Party ~~in accordance with these Bylaws.~~ without any additional monetary encumbrance beyond Dues, as defined in these Bylaws. Such right shall be sacred and inviolate and the willful disregard or abridgment of such right by an Officer or Member shall be deemed sufficient cause for the suspension of such Officer or Member as provided by these Bylaws.

# OKLP Resolution Re: Affiliate Membership Purges

## OKLP RESOLUTION 2022.01(SEC) LP STATE AFFILIATE MEMBERSHIP PURGES (Adopted 30 January 2022)

**WHEREAS**, leaders of the Libertarian Party of Delaware and Libertarian Association of Massachusetts disenfranchised political opponents primarily for internal political reasons, rather than individual behavior warranting discipline, depriving such individuals of their rights to participate and vote on party affairs; and

**WHEREAS**, these membership purges raise serious doubt that the National delegates of the aforementioned affiliates will be legitimately selected and representative of the respective affiliate's entire membership;

**WHEREAS**, the LNC has declared multiple times that the only remedy they have to an alleged purge is to disaffiliate a State Libertarian Party;

**WHEREAS**, National Libertarian Party rules dictate that no State Party can be disaffiliated within six months of a National Convention which means that no such remedy exists at this point, therefore, be it

**RESOLVED**, that the Oklahoma Libertarian Party State Executive Committee hereby urges its elected National delegates to challenge the seating of the Massachusetts and the Delaware delegations at the 2022 National Convention in Reno; and Further

**RESOLVED**, that the Oklahoma Libertarian Party State Executive Committee is hereby empowered to rescind some or all of this motion, in the event that the aforementioned affiliates restore the membership rights of the disenfranchised members in enough time that the delegations can be representative of the respective state affiliates.

# Founders Dinner Keynote Speaker

---

## **D. Frank Robinson**

Oklahoma native D. Frank Robinson was “in the room where it happened” in 1972, co-founding the national Libertarian Party with David Nolan and others. He chaired the Bylaws Committee at the first national convention and was chosen as an At Large Member of the first Libertarian National Committee. Robinson became the first Chair of the Oklahoma Libertarian Party at its founding in 1972.



In 1984, Robinson was ticketed for trespassing at the Oklahoma State Fairgrounds while gathering signatures to get the OKLP back on the ballot. The result of the subsequent lawsuit was that the right to petition on public property was upheld by the federal court. A separate lawsuit challenging the state’s ballot access law cited that harassment and resulted in the party being recognized for elections that year due to a court order as well as a permanent expansion of the time period to gather signatures for party recognition from 90 days to a year. Robinson was one of the candidates nominated by convention that year, receiving 4,470 votes (2.5%) in the 5th Congressional District.

Robinson continues to this day to pursue two main ideas. One is that electing Libertarians to Congress is the goal that best combines the priorities of achievability and effectiveness in order to advance the party’s agenda. The other and more critical notion is that the state monopolies of printed ballots which require dispensation from the state for candidates to be listed benefits the two establishment parties. Both as a matter of principle and as a means to create the basis for legal action, Robinson has attempted to file as a candidate for Congress in 2016, 2018, and 2020 without submitting either signatures or a filing fee. He declines to file with official support of the LNC as a co-plaintiff. The decision of the LNC is still pending.

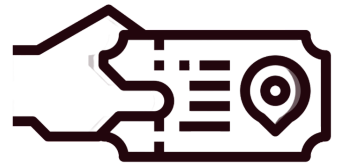

# Robert's Rules of Order Quick Reference

---

A motion is the topic under discussion (e.g., "I move that we add a coffee break to this meeting"). After being recognized by the Chair, any delegate can introduce a motion when no other motion is on the table. A motion requires a second to be considered. If there is no second, the matter is not considered. Each motion must be disposed of (passed, defeated, tabled, referred to committee, or postponed indefinitely).

## HOW TO DO THINGS:

### **You want to bring up a new idea before the group.**

After recognition by the Chair, present your motion. A second is required for the motion to go to the floor for discussion or consideration.

**You want to change some of the wording in a motion under discussion.** After recognition by the Chair, move to amend by adding words, striking words, or striking and inserting words.

### **You like the idea of a motion being discussed, but you need to reword it beyond simple word changes.**

Move to substitute your motion for the original motion. If it is seconded, discussion will continue on both motions and eventually the body will vote on which motion they prefer.

### **You have heard enough discussion.**

Move to close the debate (also referred to as calling the question). Requires a 2/3rds vote. If passed, this cuts off discussion and brings the assembly to a vote on the pending question only.

### **You believe the discussion has drifted away from the agenda and want to bring it back.**

"Call for orders of the day."

### **You are unsure whether the Chair announced the results of a vote correctly.**

Without being recognized, call for a "division of the house." A roll call vote will then be taken.

**You are confused about a procedure being used and want clarification.** Without recognition, call for "Point of Information" or "Point of Parliamentary Inquiry." The Chair will ask you to state your question and will attempt to clarify the situation.

### **You have changed your mind about something that was voted on earlier in the meeting for which you were on the winning side.**

Move to reconsider. If the majority agrees, the motion comes back on the floor as though the vote had not occurred.

### **You want to take a short break.**

Move to recess for a set period of time.

### **You want to end the meeting.**

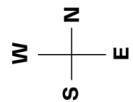
Move to adjourn.

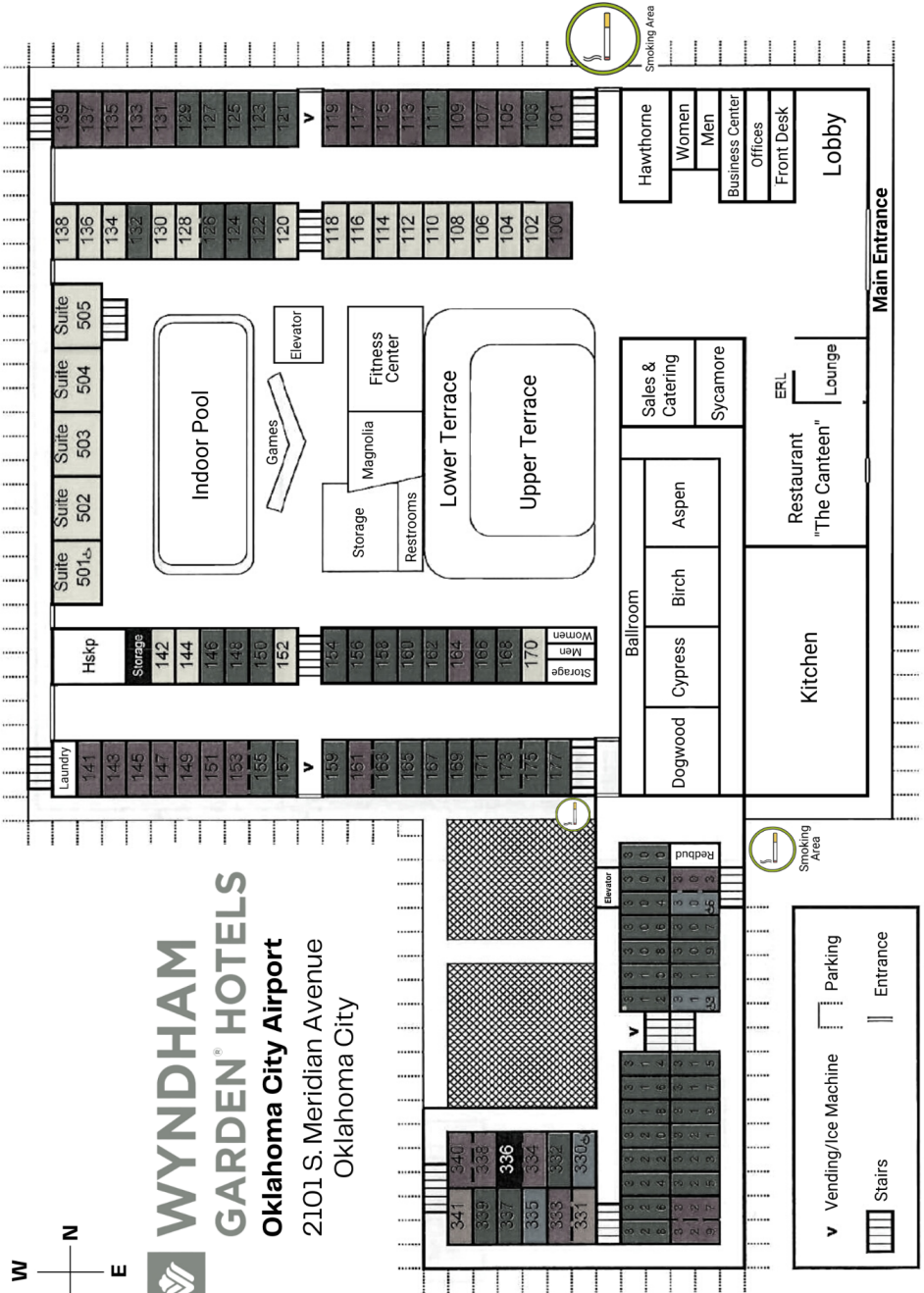
- to get information about business: [point of information](#)
