



THE CHARTER AGREEMENT BETWEEN:

Central Oklahoma Libertarian Party of The Central Region
and The Libertarian Party of Oklahoma

The Libertarian Party of Oklahoma hereafter known as The Party seeks to enable citizens of the State of Oklahoma to organize into a political party and to promote the Libertarian principles necessary to the existence of a free society by: (a) Publicizing the principles of libertarianism and securing ballot recognition and voter registration rights; (b) Seeking out, developing, nominating, and campaigning for the election to public office of Libertarian candidates who pledge adherence to the Declaration of Principles of the Party, and supporting these Libertarians during their continuance in office; (c) Extending cooperation to other organizations and groups when this furthers libertarian principles and objectives.

The Chartered Organization seeks to become an extension of The Party in the furtherance of these aims and to function within the parameters of this agreement.

The Chartered Organization agrees to:

- Create and adopt bylaws which include stated methods for electing the offices of Chair, Vice Chair, Secretary and Treasurer and providing that these positions are held by Enrolled Members of the Party as described in Article VI: Section 4.01 of The State Party's bylaws.
- Abide by all applicable campaign finance laws as determined by the State of Oklahoma.
- Conduct its program consistent with Party values and principles as represented in the national platform and/or a state platform should one be adopted.
- Never use their association with The Party to pursue any objectives outside the realm of Party objectives.
- In the event they are forming as a Student Organization, respect the rules and regulations of the institutions which govern such groups as long as they are not in opposition to the principles of the Party. The revoking of the Organization's official status by the school's governing institution is not necessarily grounds for the Party to revoke this Charter.
- Abide by a majority vote of the Executive Council to amend this Charter, a two-thirds vote of the Executive Council to revoke it or a three-fourths vote of a State Convention to revoke it.
- Oppose and reject the initiation of force to achieve political or social goals.
- Notify The Party Chair and The Party Secretary of the intent to Charter at least thirty days prior to presentation before the Executive Council for a vote or at a properly convened State Convention.

The Oklahoma Libertarian Party agrees to:

- Respect the aims and objectives of The Chartered Organization as long as there is no conflict of principles.
- Respect the voting privileges of The Chartered Organization in regards to the Executive Committee.
- Facilitate regularly scheduled opportunities for the Chairs of all Chartered Organizations to meet and exchange ideas, best practices and project proposals for the express purpose of ensuring a unified vision of activism across the state despite the individuality of each group.
