
The Quill started off in 2019 in an effort to keep our members updated on the OKLP.



CANDIDATES DRIVE THE BUS By Chris Powell Should you choose to be a

If you ask a random person on the street to name a Libertarian, there is a slim chance that they will come up with a free market economist. They might come up with some celebrity who claims the label. But the overwhelming majority will name someone who has been a candidate for office. And they absolutely will not even think about, let alone be able to identify, a national or state chair or other party official.

Most of us in the LP first became interested because of a campaign, usually for president, that brought the party to our attention. While we can't all run for POTUS, elections for Congress, state executive and legislative positions, and county and local offices are occuring all the time. Each one is an opportunity to be the gateway to libertarianism for others.

If you're interested in running for office, we'd love to hear from you! political@oklp.org Should you choose to be a candidate, you get to decide what issues you will talk about and how to present your policy preferences to voters. You are the person those voters in your district will see. During a campaign it's the candidates the media talk to, it's candidates who are invited to forums and debates, and candidates going door to door and meeting face to face with voters.

Party members, donors, activists, and party officials are all passengers, candidates drive the bus.

We need more bus routes, reaching more voters, giving more people a chance to hear first-hand about how liberty can make their lives better.

Having been a candidate myself(and gotten elected!), I've paved some new routes, but we need to reach a lot more people.

You have the opportunity be one of those leaders creating new routes to liberty, and you can also join me and other Libertarians as passengers by donating for candidate recruitment.

We need more bus drivers.

Shred the Stigma & Take Action

Interview by Victoria Lawhorn

Two-time OKLP Activist of the Year recipient and SHRED Founder and Executive Director, Drew Cook, explains how he took action to see his vision to be able to save thousands of lives realized in the span of just over a year.

Why did you decide to start SHRED? I had a really gnarly season of relapse in 2019 and I was searching for clean syringes, None of the pharmacies will sell them to you. You have to run a hustle in order to get new ones, and I'm talking to other people about that and asking around [in] a very strict circle [of drug users]. Somebody told me about this organization called SHOTS in Tulsa and they said 'Yeah, there's six people and they hand out new syringes and no questions asked.' At the time it was like a radical concept - I mean I've been an intravenous drug user out here for a lot of years; I never heard about a syringe exchange or harm reduction, foreign concept, so... that's how I heard about them. And then I found out you have to be in Tulsa so that didn't help me,

When I got back into recovery and started, you know kind of diving back into the Libertarian projects, I start it up - you know, Clean Libertarian podcast - and I brought on SHOTS. That conversation was the first ground floor understanding I had on the "Why." So I sat on that idea for about a year before I put action behind it. You know I kind of ran from it, hoping somebody else would start it up out here, and they never did so here we are.

What did you have to do to get it started?

Ask people for money. That was the biggest thing and that was the OKLP, [OKLP] members were the primary initial donors, that's where that seed money came from and then you know from there it was just kind of like, I don't know, stuff would fall in my lap.

Hardest part? Keeping up with the demand. There's a huge vacuum given the policies in the state for drug users getting access to sterile equipment and so we do our best to meet the need but it would take a full staff of 20 full-time making deliveries to make that happen.

Most rewarding? So you'll meet somebody initially, this is the first time they reached out and they're covered in sores, all over their arms, on their necks, abscesses from using the same syringe over and over and over again, and then within a matter of months of providing them the sterile equipment, those sores are gone. They cleaned up and they got housing. It's just a kind of a snowball effect and that's been incredible. Then we've seen people who've gotten into treatment and that's beautiful. You know, I love it obviously, but it's just those unsung heroes that I reflect on. Those ones that didn't know that they made a big move but I know they did.

886 Reversals & Counting

According to data in 2022 from the CDC, fentanyl-related overdoses are the number one cause of death for people ages 18-45. We're on a mission to change that. In August 2023, we reached 886 reported overdose reversals in the Oklahoma City metro area.



What advice would you give to someone wanting to start up an organization the way that you did? Do it, just do it. You know when when I started this I had no idea what it would look like. I got the seed money together and that's all I have...nothing [was] forecasted at all. I [thought] 'I will just buy the things and the rest will happen and if you care enough about something and your message is accurate and passionate people are going to hop on board.'

What do you wish you had known or done differently? I don't reckon I would change a single thing that we've done because it's been working out pretty good for us so far.

What would say to our readers? I would say I'm an individual in the Oklahoma Libertarian Party, who donated to the Bernie Sanders campaign. I'm an individual who came from the left, and to disregard an entire body of people is the most foolhardy move you could ever make. I'm not saying water down anything, but absolutely understand that your enemy is not Progressive liberals, it's the people in Washington. It's the people on 23rd and Lincoln who are screwing us on a daily basis.



OKLP Legislative At-Large Takes Oath for Board of Adjustment

Keeping cool in the Warr Acres City Council chambers on the afternoon of August 17th, OKLP Legislative At-Large Lynda Steele was sworn in by Mayor Roger Godwin as the newly-appointed Oklahoma County Representative (District 3) on the Board of Adjustment. This board, requiring one representative from each of the three Districts, meets regularly to hear appeals and to resolve errors, variances, and special requests relating to zoning matters.

Ms. Steele began her political career in April of 2022 when she opted to run for Attorney General as a Libertarian. Garnering 26.2% of the vote, as a new member of the Party, Steele broke the record for highest popular vote in a statewide race as a Libertarian. Steele has since been elected to her current position as Legislative At-Large, charged with keeping party members up to date on legislative session, and organizing party efforts to support specific legislation.

Candidate Recruitment

WHY SHOULD I RUN FOR LOCAL OFFICE?

Community Empowerment: Running for office provides an opportunity to empower your community by engaging residents in discussions about their needs, concerns, and aspirations. Your campaign can serve as a platform for community dialogue and collaboration.

Civic Engagement: By participating in the electoral process, you encourage civic engagement and active participation in local democracy. This can help increase voter turnout and overall political awareness.

Influence on Budget and Spending: Local officials have a role in budget allocation and spending decisions. As a libertarian, you can work to prioritize fiscal responsibility, efficient resource allocation, and reducing unnecessary government expenditures.

Pathway to Higher Office: Serving in local office can serve as a stepping stone to higher levels of government, if that is your long-term goal. It allows you to gain experience, build a track record, and develop a broader network of contacts within the political arena.

Duties of the Political At-Large include:

- Develop and execute an overarching political strategy to enhance Libertarian campaign outcomes.
- Collaborate closely with the State Chair to identify strategic districts and races for Libertarian candidates.
- Seek out potential candidates who align with Libertarian values.
- Aid in recruiting, training, and supporting Libertarian candidates and their campaign teams.
- Provide guidance on campaign organization, strategies, and best practices.
- Assist in the overall coordination and management of campaign efforts.

Duties of the Legislative At-Large include:

- Work alongside the Chair on legislative matters relevant to the Party's interests.
- Evaluate state legislation to determine the Party's stance on bills to support or oppose.
- Engage with the legislature and its subcommittees to advocate for Libertarian positions.
- Compile information for calls to action and membership involvement.
- Contribute to Party resolutions, press releases, and statements regarding legislative matters.
- Help organize Party lobbying events, rallies, and grassroots advocacy.

Where Do | Start?

Find out who your legislators are by visiting <u>Oklahoma House</u> <u>Representatives</u>, <u>Oklahoma</u> <u>Senators</u>, or using the mobile app, <u>OAEC 59</u>.

Get In Touch:

- Phone Calls: Calling their offices allows for direct communication and immediate feedback.
- Emails: Sending emails provides a written record of your concerns and allows you to communicate more indepth.
 - Letters: Physical letters can have a personal touch and demonstrate dedication to an issue.
 - In-Person Meetings: Requesting meetings with legislators or attending town hall events provides face-toface interaction.

How Do You Do?

Be Clear and Concise:

Clearly state the issue you're concerned about, why it matters to you, and what action you'd like the legislator to take. Provide relevant facts, data, and personal stories to support your position.

Respectful Communication:

Maintain a respectful tone, even if you disagree with the legislator's stance. Professional and courteous communication is more likely to be taken seriously.

Follow Up:

If you receive a response, acknowledge it and continue the conversation if necessary. If your legislator takes action on your concern, express gratitude.

Other Ways to Make an Impact


Advocate in Groups: Collaborate with libertarians or advocacy groups to amplify your message and increase the impact of your advocacy efforts.

Utilize Social Media: Many legislators are active on social media platforms. Engaging with them on these platforms can help raise awareness and draw attention to important issues.

Participate in Public Hearings: Many legislative bodies hold public hearings where constituents can provide testimony on specific issues. Participating in these hearings allows you to directly address lawmakers.
